There is no appeal. By law, neither the school's president nor the US Department of Education can override the financial aid administrator's decision. Legislative Authority. The authority to conduct professional judgment reviews is granted by sections 479A and 480(d)(7) of the Higher Education Act of 1965. Section 479A is concerned with the authority to adjust data elements of the FAFSA application and the authority to refuse to certify a student loan.
