Subordinate legislation Subordinate legislation can only be made if primary legislation confers a power to do so. The primary legislation is known as the enabling act, because it enables the subordinate legislation to be made.

Delegated legislation. Delegated (also known as subordinate) legislation is legislation made not directly by an Act of the Parliament, but under the authority of an Act of the Parliament. Parliament has regularly and extensively delegated to the Executive Government limited power to make certain regulations under Acts.

## **The Constitution - Subordinate Legislation**

Both article 9.4 and 9.5 of Regulation 2065/2003 specified in that Schedule apply to both “an authorised product” and “a derived smoke flavouring produced from an authorised product”. The effect of being specified in the Schedule is to make non-compliance with the provision an offence.
