## **Application for Certified Copy of Birth Certificate**

Concerning the child, the application form asks for a name, date of birth, place of birth, weight, height, and other vital statistics. The form also asks if the child was born in a hospital, if it's a twin or "multiple," and if the child was born with any health conditions.

## **Birth Certificates**

NOTE: Birth Certificates are confidential records and copies can only be issued to a person entitled to receive them. The application must indicate the requestor's relationship to the person listed on the record and indicate the intended use of the document.

## **Application for Illinois Birth Record**

Identity of applicant will be screened using SSN. Valid ID or alternative ID required. Vital records are the legal records documenting a vital event, such as a birth, death, marriage, Oregon Registered Domestic Partnership, divorce, or fetal death. Birth certificates are the primary documents used to establish identity.

## **Birth | Florida Department of Health**

Birth records are public information 100 years after the date of the event; death, marriage, and divorce records, 25 years after the event. Vital Records are available to immediate family members only- mother, father, husband, wife, child, brother, sister and grandparents with valid ID. Birth records can be issued to the legal guardian with proof of custody papers. Aunts, uncles, cousins, in-laws, etc. cannot obtain a Vital Record.

## **Vital Records - Virginia Department of Health**

The California Department of Public Health - Vital Records (CDPH-VR) maintains birth, death, fetal death/still birth, marriage, and divorce records for California. Services provided by CDPH-VR include issuing certified copies of California vital records and registering and amending vital records as authorized by law.

## **Vital Records**

Birth records are also available from the local Registrar of Vital Statistics where the event occurred. Requirements Who is eligible to get a copy of a birth certificate? The person named on the birth certificate. A parent of the person named on the birth certificate. The requesting parent's name must be on the birth certificate.

You may submit this request by mail or in person at a regional vital records office or the DHEC State Vital Records Office in Columbia. Mail requests generally take up to 4 weeks for an initial response.
