Whether you have to work on a holiday depends on whom you work for, whether you are covered by a union contract, and company policy regarding holidays. If you work for the federal government, you'll get 10 paid holidays each year including New Year's Day, Birthday of Martin Luther King, Jr., Washington's Birthday (also known as President's Day), Memorial Day, Independence Day (4th of July), Labor Day, Columbus Day, Veterans Day, Thanksgiving Day, and Christmas Day.

Do You Get Paid Extra for Working on a Holiday?

The Fair Labor Standards Act (FLSA) does not require payment for time not worked, such as vacations or holidays (federal or otherwise). These benefits are generally a matter of agreement between an employer and an employee (or the employee's representative).

Under federal law, a holiday doesn't have a special designation for overtime pay, nor is working on a holiday considered overtime. Federal law views holidays as just another business day. That said, both federal and state law requires most employers, but not all, to pay overtime to employees whose hours meet the criteria.

Aren't I entitled to extra pay, of at least double time, for working on a holiday? A. There is nothing in state law that mandates an employer pay an employee a special premium for work performed on holidays, Saturdays, or Sundays, other than the overtime premium required for work in excess of eight hours in a workday or 40 hours in a workweek.

Calculation of hours worked over a period of 12 months. Consider a worker who work 35 hours per week, 4 vacation weeks and 5 public holidays (for a total of 5 weeks of vacation). 35 hours per week x (52 weeks in one year - 5 weeks of holidays) = 1,645 hours worked per year
